***G.S.R. 1 (E).**— In the notification of the Government of India in the Ministry of Health and Family Welfare (Department of Health), number G.S.R. 398(E) dated the 3rd July, 2006, published in the Part II, Section 3, Sub-section (i) at pages 1-68 of the Gazette of India, Extraordinary,-

1. At page 36, in rule 1(2), for the words "after six months" read the words "after nine months".
2. At page 41, in the last line, for the words and figures, "100 K. Calorie", read "100 kcal".
3. At page 45, in 1st Table, in the columns for Food additives and Maximum level in 100 ml of the ready-to-drink product—
 - (a) after words, "L(+) Lactic acid", insert "L(+) Lactic acid producing cultures".
 - (b) at the end, after the word, "Citric acid", insert the following:-

4. At page 46, after the proviso—
 - (a) in para (i), for the word and figures, "per 100 K. Cal/Joules" read "100 kcal".
 - (b) in para (ii)—
 1. in 1st line, for the words and figures, "0.5/gram per 100 K Cal" read "0.5 gram per 100 kcal";
 2. in the last line for the words, "less than" read, "not less than".
5. At page 47, after the second proviso, in para (i), for the words, "casein", read, "whey or casein".
6. At page 48, in ninth line, for the words, "casein", read, "protein".
7. At page 50, in the second Table, against entry 2, for the figure, "12.0" read, "15.0".
8. At page 51,--
 - (a) in the Table, against entry 7, for the figure, "0.1" read, "1.0".
 - (b) in the last line, for the words, "quality of protein" read, "PER".
9. At page 59, in the second Table, against entry 3—
 - (a) after the words, "Linoleate" insert "per 100 gram".
 - (b) for figures and the word, "1.398 gm" read "1.398",
10. At page 60, in the Table against entry 7, for the figure, "75" read, "350".
