

MEAT FOOD PRODUCTS (AMENDMENT) ORDER, 2005

MINISTRY OF FOOD PROCESSING INDUSTRIES

ORDER

New Delhi the 24th October, 2005

***S.O. 1545(E)** – In exercise of the powers conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955), the Central Government hereby makes the following Order further to amend the Meat Food Products Order, 1973, namely:-

1. (1) This Order may be called the **Meat Food Products (Amendment) Order, 2005**.

(2) It shall come into force on the date of its publication in the Official Gazette.

2. In the Meat Food Products Order, 1973 (hereinafter referred to as the said Order),

(A) in paragraph 2 -

(i) in sub-paragraph (a), after the words "and includes poultry", the words "and fish" shall be inserted;

(ii) in sub-paragraph (j), -

(a) after the words "drying, curing, smoking, cooking, seasoning, flavouring", the word "freezing" shall be inserted;

(b) after sub-clause (vi), the following sub-clause shall be inserted, namely:-

"(vii) Chilled poultry",

(B) in paragraph 4, in sub-paragraph (3), for the Table, the following Table shall be substituted, namely:-

3. in the said Order -

(a) in the First Schedule -

(i) in FORM 'A', after item-1 and the entry thereof, the following shall be inserted, namely:-

"1A. Telephone number and Fax number";

(ii) in FORM 'B', after serial number 2 and the entry thereof, the following shall be inserted, namely:-

"3. Source of raw meat";

(b) in the Fourth Schedule, in paragraph 11, in sub-paragraph (1), after item (e), the following shall be inserted, namely:-

"(f) The Prevention of Food Adulteration Act, 1954 (37 of 1954) standards shall be adopted wherever applicable".
