G.S.R. 498(E).- The following draft of certain rules further to amend the Prevention of Food Adulteration Rules, 1955, which the Central Government, after consultation with the Central Committee for Food Standards, proposes to make in exercise of the powers conferred by sub-section (1) of section 23 of the Prevention of Food Adulteration Act, 1954 (37 of 1954), is hereby published, as required by the said sub-section, for the information of all persons likely to be effected thereby; and notice is hereby given that the said draft rules will be taken into consideration on or after the expiry of a period of sixty days from the date on which copies of the Gazette of India in which this notification is published, are made available to the public;

The objections or suggestions, which may be received from any person, with respect to the said draft rules, before the expiry of the period so specified, will be considered by the Central Government.

DRAFT RULES

- 1. (1) These rules may be called the Prevention of Food Adulteration (.........Amendment) Rules, 2008.
- (2) They shall come into force on the date of their final publication in the Official Gazette.
- 2. In the Prevention of Food Adulteration Rules, 1955 in rule 65, in sub-rule (2), in the table,-
- (i) against serial no. 4, in columns (3) and (4), after the existing entries, the following shall be inserted, namely:-
