PREVENTION OF FOOD ADULTERATION (VIIITH AMENDMENT) RULES, 2006

***G.S.R. 633(E).-** Whereas certain draft rules further to amend the Prevention of Food Adulteration Rules, 1955 were published, as required by sub-section (1) of section 23 of the Prevention of Food Adulteration Act, 1954 (37 of 1954), in the Gazette of India vide notification of the Government of India in the Ministry of Health and Family Welfare (Department of Health), number G.S.R. 7(E), dated the 9th January, 2006, inviting Objections and suggestions from all persons likely to be affected thereby till the expiry of a period of sixty days from the date on which copies of the Official Gazette containing said notification, were made available to the public;

And whereas, the copies of the said Gazette were made available to the public on the 13th January, 2006.

And whereas, objections and suggestions received from the public within the specified period on the said draft rules have been considered by the Central Government;

Now, therefore, in exercise of powers conferred by section 23 of the Prevention of Food Adulteration Act, 1954 (37 of 1954), the Central Government, after consultation with the Central Committee of Food Standards, hereby makes the following rules further to amend the Prevention of Food Adulteration Rules, 1955, namely:-

1. (1) These rules may be called the **Prevention of Food Adulteration (VIIIth Amendment) Rules, 2006**.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Prevention of Food Adulteration Rules, 1955, in rule 65, in sub-rule(2), in the Table,-

(a) against serial number 42 relating to Decamethrin/Deltamethrin, in columns (3) and (4), after the entries, the following entries shall be inserted, namely:-
