

# PREVENTION OF FOOD ADULTERATION (.....AMENDMENT) RULES, 2006

## NOTIFICATION

New Delhi, the 13<sup>th</sup>/21<sup>st</sup> July, 2006

**\*G.S.R. 439(E).**- The following draft of certain rules further to amend the Prevention of Food Adulteration Rules, 1955, which the Central Government, after consultation with the Central Committee for Food Standards, proposes to make, in exercise of the powers conferred by sub-section (1) of Section 23 of the Prevention of Food Adulteration Act, 1954 (37 of 1954), is hereby published, as required by the said sub-section, for the information of all persons likely to be affected thereby, and notice is hereby given that the said draft rules will be taken into consideration after the expiry of a period of sixty days from the date on which copies of the Official Gazette in which this notification is published, are made available to the public;

Objections or suggestions, if any, may be addressed to the Secretary, Ministry of Health and Family Welfare, Government of India, Nirman Bhawan, New Delhi - 110011;

The objections and suggestions, which may be received from any person with respect to the said draft rules before the expiry of the period so specified will be considered by the Central Government.

### DRAFT RULES

1. (1) These rules may be called the **Prevention of Food Adulteration (.....Amendment) Rules, 2006.**

(2) They shall come into force on the date of their final publication in the Official Gazette.

2. In the Prevention of Food Adulteration Rules, 1955, (hereinafter referred to as said rules), for rule 48-C, the following rule shall be substituted namely:-

**"48-C. Sale of Food Additives.**- The food additives mentioned in column (3) of the Table given below, permitted for use in certain foods, shall conform to Bureau of Indian Standards (BIS) specification in column (2) of the said Table as amended from time to time, namely:-
